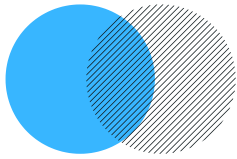


HELP! TRAUMA IS IMPACTING OUR STUDENTS

Our students, families, and districts face many challenges of complexity that impact their mental health. In addition, these challenges externalize through behaviors which then show up in the classroom and at home. This training will look at reasons behind disproportionality, suspension rates, and servicing students of color from the lens of intersectionality between trauma and equity. Participants will gain experiential understanding in the "why" behind the low attendance rates and high suspension rates. Participants will also learn strategies to bridge the gap between unwanted externalized behaviors and gain applicable tools to increase rapport and relationship. We will discuss the tier 1, tier 2, tier 3 and tier 4 students and how to best support all students through Trauma Informed Care.

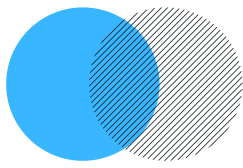

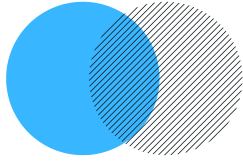

By creating a strong Tier 1 support system on the MTSS pyramid, all students are given equal opportunity and access to the curricula and the school as a whole. The UDL framework and Differentiated Instruction supports not only students, but the staff and community as well. The flexibility and individuality of these frameworks meet the learner where s/he is currently, and not where they are expected to be.

ADDRESSING TRUANCY FOR STUDENTS WITH IEP'S & 504'S

Truancy and students with disabilities is one of the most challenging issues faced by administrators and special educators, implicating virtually every aspect of the IDEA and Section 504.

Attendance issues pertaining to students with IEPs or 504 plans must be handled with care. Although these students are subject to compulsory education laws, administrators must be aware of how attendance issues may lead to a suspicion of a disability triggering the requirement to assess the student and, if eligible, develop an appropriate IEP or 504 Plan.

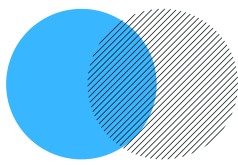
Administrators also need to avoid discriminatory application of attendance policies. Finally, disciplining these students by removing them from school may trigger the requirement to conduct a manifestation determination.

In 1988 Senate Bill 933 establish the State Ombudsman for the Foster Care Program within the State of California. The Ombudperson's Office focuses on ensuring the rights Foster Care are supported. Join this action-packed workshop to learn about foster youth rights! All participants will receive helpful information about the Foster Youth Bill of Rights, mental health rights, sexual and reproductive health rights, and education rights. Participants will also learn tips and tricks to effectively engage and empower youth with their rights.

As an occupational therapist, Dr. Dolin has a unique perspective on how students learn and how lessons can be augmented to reach all students. YOUTH MENTAL HEALTH FIRST AID TRAINING
DAN SACKHEIM & DAVID KOPPERUD

YMHFA training is based on the concept of medical first aid for educators and other adults working with students, ages 12-18, to help them identify mental health issues earlier, allowing students more opportunity to overcome barriers to their education. Participants learn a five-step action plan to offer initial help to young people showing signs of a mental illness or in a crisis and to connect them with the appropriate professional, peer, social, or self-help care. The training also introduces common mental health challenges of youth, reviews typical adolescent development, and reviews strategies to help young people in crisis and non-crisis situations.

Project Surf Camp is an amazing experience for students with special needs, adults with special needs, and at risk students. Through surfing and stand up paddle boarding, participants build self confidence, self-esteem, self-efficacy, and foster independence, while providing opportunities to build social skills, improve physical fitness, and develop healthy outlets for stress reduction.

This is an opportunity for you to experience Project Surf Camp and learn how your students can benefit from attending a camp. You will be able to see first hand how the amazing staff works the participants and "changes lives". If you have traveled with your family they are welcome to join you for this experience.
